Management structure of LIFE Programme




European Commission

European commission – responsible for implementation of EU policies through LIFE Programme.

European Climate, Environment and Infrastructure Executive Agency (CINEA) – CINEA has started activities since 1 April 2021.

The Executive Agency besides LIFE Programme is entrusted with the implementation of Union programmes such as: Public sector loan facility, under the Just Transition Mechanism; European Maritime, Fisheries and Aquaculture Fund; Horizon Europe: Pillar II, cluster 5: Climate, energy and mobility, etc. (https://cinea.ec.europa.eu/index_bg)







Functions of the National Contact Points



National Contact Point (NCP)

NCP in Bulgaria is positioned at the Ministry of Environment and Water, Coordination of EU Affairs and International Co-operation Directorate.

Functions of the National Contact Points



Strategic functions

- ❖ Participation in the LIFE programming process providing of opinion on drafts of legislation under the Programme, incl. and the respective amendments
- ❖ Participation in the approval of LIFE priority topics and the Multiannual Work Programme for the Implementation of the LIFE Programme (2021 − 2024; 2025 − 2027)
- ❖ Participation in the decision making of other key EC decisions in regard to the Programme
- ❖ Participation in working bodies, groups and events at Programme level, including LIFE Committee meetings, NCP trainings, member states experience exchange, etc.
- Organization of the coordination and demarcation of project proposals and beneficiaries at national level



Functions of the National Contact Points



Programme implementation functions

- ❖ Ensuring publicity publication and dissemination of information about the Programme applicable legislation and other relevant documents; forthcoming and open calls; LIFE initiatives e.g. LIFE awards and other events related to LIFE.
- Knowledge and awareness raising for elaboration of qualitative and competitive projects and for the implementation of LIFE – organization of Info days, seminars, conferences and other events; website maintenance - http://www.life-bulgaria.bg and presence in social media— Facebook page "Προγραμα LIFE".
- Consultations of potential beneficiaries incl. issue of declaration of support from the competent authority
- ❖ Participation in monitoring missions within implemented projects in Bulgaria



What should we pay attention to in the project proposal preparation process



- Regular monitoring of LIFE information channels aiming to the timely acknowledgement of the funding opportunities and ensuring enough time for development of qualitative projects
- Sound knowledge of the current strategic and legislative basis in the respective area at EU, national and regional level ensures the proper compliance of the project idea and the project contribution to the achievement of the documents targets/results
- !!! In order to submit a project proposal it is compulsory to have a registration at https://ec.europa.eu/info/funding-tenders/opportunities/portal/screen/home
- ❖ Get familiar with the projects data base ideas for upscaling, application of best practices and innovative techniques, methods and approaches and gaining general idea of the Programme.
- Finding of appropriate partners that really have added value in the project implementation; opportunity to use the platform for partner search http://www.life-bulgaria.bg/bg/partners/
- Knowing award criteria to understand the advantage that your project could take in front of the other projects submitted at EU level
- ❖ Don't wait for the last moment to submit your project e.g a technical time is needed to proceed the declarations of support from the competent authority http://www.life-bulgaria.bg/bg/programa-life/pravila-za-podavane-na-dokumenti-za-izdavane-na-pismo-za-podkrepa/
